January 12, 2018, 1:00 PM

The meeting of the Board of Trustees of **KIPP ACADEMY LYNN CHARTER SCHOOL and KIPP ACADEMY BOSTON CHARTER SCHOOL** (collectively, the "<u>Schools</u>") convened at 1:00 p.m. on January 12, 2018, at 75 Pleasant Street – Rooms 137ABC, Malden, Massachusetts, held in compliance with the open meeting laws, at which a quorum of the Trustees was present. Topics of focus during the interview included ensuring quality of academic programming, timing and scope of the increase request, actions taken to prepare operations and staffing structures to support additional students, previous elementary and secondary academic results at KIPP Academy Lynn Charter Schools (KALCS) and KIPP Academy Boston Charter Schools (KABCS), student support programming, discipline rates, and the qualifications of potential school leaders, Emily DoBell and Farida Mama Graham.
